**Announcement on Additional Examinations to be Given to  
Unsuccessful Students Who Will Complete Their Maximum  
Education Duration at the end of 2021-2022 Fall Semester based  
on Article 44/C of Law No. 2547 of Higher Education Law (YÖK)**

Students who complete their maximum education duration will be given the right of additional examination in accordance with the Law No. 6569 Article No. 28 effective from 26.11.2014 related to Higher Education Law, regarding the Education Duration (Law No 2547, Article No.44). Students who have completed their maximum education duration at the end of 2021-2022 Fall Term however would like to benefit from additional examination rights;

*Final year students whose maximum education duration will be completed at the end of 2021-2022 Fall Term will be given,*

- 1) Two additional examination rights for the courses not taken before and with Failed / Not Attended grades (except practical courses). Students who reduces the number of the failed course to five courses will be given three semesters for those five courses,
- 2) Students whose failed courses are up to five courses without attending the examinations will be given four semesters (two academic years for the institutions with class-year education basis),
- 3) Students who have only one failed course will be given unlimited rights to attend the examinations of the failed course without benefiting the student rights.
- 4) Final term students (Final Year students for the institutions with class-year education basis) who will be discharged due to their inability to provide the compulsory GPA specified within their regulations though have been graded with passing scores to graduate from their programs will be given

unlimited rights to attend the examinations of the requested courses.

\* Attendance is not required for the courses except practical, with practice and never been taken before.

\*\* A student who never attends the examinations to be opened for three consecutive or intermittent academic years will be deemed to waive from her/his rights of unlimited examinations and could not benefit this right.

\*\*\* Students to benefit Additional Examinations or Unlimited rights continue to pay the contribution fee/tuition fee for each of the course/s. (For 2021-2022 Academic Year, **Undergraduate Degree 1.050 TL, Associate Degree 525 TL, Vocational School of Justice 600 TL**) Nevertheless, those students could not benefit student rights except examination rights.

**5) Students whose remaining courses are ~~six(6)~~ and above for graduation upon benefiting **two (2)** additional examination rights at the end of their maximum duration will be discharged**

**6) English Language Preparatory Year students who was discharged at the end of the maximum duration effective from 2017-2018 Academic year will benefit **three (3) (FLAT)** examination rights for once due to Covid 19 pandemics on condition that **they will apply till 31<sup>st</sup> of January, 2022.****

**7) Associate degree students, utilized or not utilized additional examination rights owing to maximum duration, **who was discharged** due to remaining **5 and above** failed, not attended or never been taken courses before 2019-2020 Academic Year will benefit additional examination rights for once due to Covid 19 pandemics for the courses **they never took before and/or failed due to not attending** on condition that **they will apply till 31<sup>st</sup> of January, 2022.****

**8) Associate degree students, utilized or not utilized additional examination rights owing to maximum duration, **who was discharged** due to remaining **5 and above** failed, not attended or never been taken courses on 2020-2021 Academic Year will benefit additional examination rights for once for the courses **they never took before** on condition that **they will apply till 31<sup>st</sup> of January, 2022.****
