REGISTRATION PROCESS AND NECESSARY DOCUMENTS

Students who have awarded to register Double Major or Minor Programs should visit **Student Affairs Directorate Support Platform** from <https://oimdestek.yasar.edu.tr/> and choose “Applications” first and then they will fill up the Double Major Program Registration Form or the Minor Program Registration Form according to the program they have awarded from the same step.

COURSE SELECTION AND REGISTRATION PROCESS FOR DOUBLE MAJOR AND MINOR PROGRAMS

Students who have awarded to register Double Major or Minor Programs, will make their course registrations in accordance with the rules broadcasted within the link of <https://oim.yasar.edu.tr/en/wp-content/uploads/2022/01/majorinfo.pdf>

WHAT TO CONSIDER DURING COURSE REGISTRATION PROCESS FOR DOUBLE MAJOR PROGRAM?

- (1) Students should complete the course load for their Major Program **first** for the valid term.
- (2) Term-based course load for Double major program is limited to **20 ECTS** with registration to **3 courses** at the same term maximum.
- (3) Students could register to courses of **50 ECTS maximum** per term with their Major programs.
- (4) Limits specified at article 2 are not applied to the courses to be registered for Double Major program during the graduation term or following graduation.
- (5) Should double major course programs coincide with major course program, students could not register to courses of double major programs that coincide with major course programs..

WHAT TO CONSIDER DURING COURSE REGISTRATION PROCESS FOR MINOR PROGRAM?

- (1) Students should complete the course load for their Major Program **first** for the valid term.
- (2) Term-based course load for Minor program is limited to **12 ECTS** with registration to **2 courses** at the same term maximum.
- (3) Students could register to courses of **42 ECTS** maximum per term with their Major program.
- (4) Limits specified at article 2 are not applied to the courses to be registered for Minor program during the graduation term or following graduation.
- (5) Should minor course program coincide with major course program, students could not register to courses of minor programs that coincide with major course programs.
